# **Czech Republic - Passenger vehicle**

#### **General Rental Information**

The renter and the driver must present a valid driver's license and an identity card or passport while pickup of the vehicle.

Driving license printed with non Roman Alphabet (Arabic, Japanese, Cyrillic etc) must be complemented by an International driving license. For driving licenses from countries not part of theGeneva/ Vienna Convention on Road Traffic (e.g. China), the International driving license is required, since an official translation of the license in English presented together with the original license might not accepted by the Police in an individual circumstances.

Customer acknowledges that cars are can be equipped with monitoring and communication safety units.

#### **Age Restrictions**

In Czech Republic, the following rules apply for the minimum age and possession of a driver's license:

- a) 18 years for vehicles in groups MCMN, MTMR
- b) 20 years/2 years for vehicles in groups EDMR, EWMR, CLMR, CFMR, CFMR, CFMR, ILMR, ILMR, ILMR, ITMR, IWMR, IWMR
- c) 21 years/2 years for vehicles in groups CCCC, IVMR, IVAR, SDMR, SDAR, SFMR, SFAR, SVMR, SVAR, FDMR, FDAR, FFAR, FVMR, FVAR, FWMR, FWAR, PDMR, PDAR
- d) 25 years/2 years for vehicles in groups PFAR, LDAR, XDAR, XTMR

An extra fee of 494 CZK/day (max value of 7 days) must be paid by drivers under 21 years of age for car groups EDMR, EWMR, CLAR, CLMR, CFAR, CFMR, CWMR, ILMR, ILAR, ITMR, IWMR, IWAR and by drivers under 23 years of age for car groups IVMR, IVAR, SDMR, SDAR, SFMR, SFAR, SVMR, SVAR, FDMR, FDAR, FFAR, FVMR, FVAR, FWAR, FWMR, PDMR, PDAR.

Drivers aged 65 years or above must show medical certificate that driver is competent to drive. Otherwise CDW/TP protection is not valid and driver is liable for the car in full amount (excess 100%).

### **Conditions of Payment**

## Generally Flexi (Tariff - Pay later and Prepaid tariff - Pay now)

The renter is obliged to pay a deposit for a rental as a guarantee for damages and other additional costs for the use of the car. The minimum amount is 25,000.00 CZK up to 250,000.00 CZK according card type and car group. Different amounts are possible. The exact deposit is determined on collection. The customer pays the deposit by credit card. Corporate customers with approved invoicing may not pay a deposit.

Please note, that payments with credit card may require the PIN of the credit card.

We accept all credit cards from internationally recognised credit card companies - such as American Express, Diners Club, Eurocard/Mastercard, Visa. We do not accept any prepaid cards or debit cards (Visa Electron). Cash Payment is not accepted. Sixt CarExpress Service Card is only accepted in combination with a valid Credit Card. On booking any vehicle category, the credit card will be charged in the event of cancellation within 24 hours of the supposed collection or if the vehicle is not collected. The amount debited to the credit card is 500.00 CZK in case of cancellation or/and in case of non-collection (no-show).

## Prepaid tariff - Pay now (special conditions)

The renter must be the owner of the indicated creditcard. The authorised driver details and method of payment will be confirmed at reservation stage and cannot be amended. The confirmed credit card should be valid and available for presentation on collection of the vehicle. All extra costs that occur during the car rental will be charged to this credit card.

By booking of a prepaid rate, the credit card will be charged before the start of rental, directly with the estimated total amount of rental. The amount that will be charged on your credit card comprises the price of rental as well as all additional extra fees.

The rental charge (plus any other charges agreed such as, e.g. exemptions from liability, delivery charges, airport charges etc.) plus value added tax in the statutory amount applicable from time to time must, as a matter of principle, be paid in full for the agreed rental period, i.e. if the vehicle is collected late or returned early there shall be no refund.

### **Changing booking**

A booking can be changed up to 48 hours before the start of the rental (on availability) in return for an alteration charge of 500.00 CZK. Any payment already made towards the rentalwill not be refunded; nor shall any differential amount be refunded if this alteration leads to a lesser rental cost.

#### Cancellation

A booking can be cancelled before the rental begins. In the event of cancellation, the payment in advance already made towards the rental shall be paid back subject to a cancellation charge, which will be withheld and shall be in the amount of the rental charge (including any extras and charges) for a maximum of 3 rental days. In the event that the booked vehicle is not collected or not collected at the agreed time the rental charge already paid shall be withheld in full.

### **General Protection Conditions**

### Third Party Insurance (TI)

Protection coverage for the vehicle rented includes Third Party Liability with a maximum cover of CZK 100 Mill for personal injuries and material damages. Excluded from the protection is the use of the vehicle for the transport of dangerous goods. All protection as part of the rental contract will become void, in particular, if an unauthorized driver has used the vehicle or if the driver of the vehicle does not possess the required driver's license at the time of the event giving rise to claim.

#### **Collision Damage Waiver (CDW)**

Collision Damage Waiver removes the drivers responsibility to a part of the vehicle in case of damage. Damages to the vehicle's driver set, key, wheel hubs, tyres and wheel damages are not covered by any protection and will be charged to the renter.

If CDW is not accepted the customer will be held liable for the full value of the car. If CDW is accepted, customer is only responsible for the following amounts:

#### **Top Cover TP**

If TP is already included in the rates, the renter can choose Top Cover TP to reduce the Non-Waiverable Responsibility. If Top Cover TP is accepted, customer is only responsible for the following amounts: 25,000.00 CZK (all car groups)

## **Super Top Cover TP**

If Top Cover TP is already included in the rates, the renter can choose Super Top Cover TP to reduce the Non-Waiverable Responsibility. If Super Top Cover TP is accepted, customer is only responsible for the following amounts:

### Personal Accident Protection (PAP)

By taking out personal accident protection can also be extended to cover the consequences of an accident.

By taking out PAP the limit of liability is:

179,550.00 CZK for invalidity,

88,200.00 CZK for decease.

No cover for medical costs.

# Tyre and Windscreen Coverage (GT)

Tyre and Windscreen Coverage provides cover against the consequences of damages on tires and windscreen.

If GT is not accepted the customer will be held liable for the full value of damages on tires and windscreen.

If GT is accepted, customer is only responsible for the following amounts: 0,00 CZK.

### **Roadside Protection (BC)**

Our Roadside Protection is your extended breakdown protection during your rental and protects you at home and abroad against high service and repair costs for the following incidents caused by you:

- 1) Key locked in vehicle: In the event of the key being locked inside the vehicle, Sixt shall assume the costs for the vehicle to be opened by the vehicle manufacturer or one of its partners, or for the vehicle to be towed away and/or for a replacement vehicle.
- 2) Breaking caused by lack of fuel: In the event of a breakdown due to having run out of fuel, Sixt shall assume the costs for breakdown assistance (delivery of the fuel). The value of the fuel will be charged to the customer.
- 3) Assistance with starting necessitated by flat battery: In in the event of assistance with starting being needed, Sixt shall assume the costs for assistance by the vehicle manufacturer or one of its partners.
- 4) Loss of key: In the event of a lost key, Sixt shall assume the costs for providing a spare key, the transport/shipping of the spare key, or for the vehicle to be towed away or for a replacement vehicle. The costs for the car locks exchange, due to the security reason is not covered.
- 5) Vehicle stuck: In the event that it is not possible to move the vehicle (eg due to wintery road conditions) Sixt shall assume the costs for the vehicle to be towed away or for a replacement vehicle. All services may only be ordered by a direct claim with Sixt 24-hour Roadside Assistance (only CZ contact in the DriverSet in the car). They shall also determine the type and extent of service required to ensure the renter stays mobile. If any damage to the rental vehicle occurs which is not covered by Sixt within the scope of the Roadside Protection, the renter is liable for such damage.

### **Delivery & Collection**

### **During Opening Hours**

Within city limits a Delivery/Collection Service is on request and the charge of 500.00 CZK applies. Outside city limits 30.00 CZK per km applies. Comsuption of the petrol is 50:50 lessor/renter. For delivery to the city centre an additional tourism tax may apply.

#### **Out of Opening Hours**

Delivery/Collection Service is on request. Please contact the local reservation centre - +420 222 324 995. An out of opening hours charge for Delivery/Collection Service may apply.

#### **Out Of Hours**

An additional surcharge of 1,620.00 CZK per each started 120 mins applies for all bookings/rentals out of hours. An Out Of Hours pick-up is on request only - please contact local reservation centre - +420 222 324 995.

### **Cross Border Rentals & Territorial Restrictions**

Cross Border Rentals are allowed to the following countries:

Austria, Belgium, Denmark, France, Germany, Hungary, Italy, Liechtenstein, Luxembourg, Monaco, Netherlands, San Marino, Slovakia Switzerland.

It is not allowed to ship the rental car by ferry. Except from: Great Britain and Ireland.

Cross Border Rentals to: Croatia, Estonia, Great Britain, Ireland, Lithuania, Latvia, Norway, Sweden and Slovenia are allowed with the exception of the following vehicle group: ILMR, ILAR, IVMR, IVAR, SDMR, SFMR, SFAR, SVMR, SVAR, FDMR, FDAR, FFAR, FVMR, FVAR, FWMR, FWAR, PDMR, PDAR, PFAR, LDAR, XDAR, XTMR.Poland you can enter with the exception of the following vehicle group: IVMR, SFMR, SFAR, SVMR, SVAR, FFAR, FVMR, FVAR, PDMR, PDAR, PFAR, LDAR, XDAR, XTMR, Mercedes (SVMR, SVAR). In case of offence against Cross Border & Territorial Restrictions all protections lose their validity.

## **Foreign Use Charge**

A foreign use charge of 968.00 CZK per rental applies.

### **Terminal 3 PRG Drop off Service**

The Terminal 3 Drop off Service can, upon request, be booked for a fee of 500.00 CZK plus parking fees. With this service the customer is allowed to return the vehicle at a desired terminal. A Sixt-agent will collect the vehicle and carry out the return process at the terminal.

### Other charges and taxes

#### **Registration Fee/Road Tax**

A Road Tax of 125.00 CZK per day.

#### Extras

Accessories are bookable without obligation and subject to availability.

### Car winterisation

During the period of November 1st until March 31 the winterisation fee of 200.00 CZK per day (max value of 7 days) will be charged. As the winter condition for cars are arranged by the lessor, as well as

winter tyres or winter liquids to the engine or front window cleaning can. The driver know tha winter tyres are mandatory in the Czech Republic.

#### Baby and child seats

Baby seats, child seats and booster seats are available subject to a fee.

#### **Navigation system**

Navigation systems are available subject to a fee.

#### Winter extra equipment

Snow chains and ski racks are available subject to a fee.

### **Diesel option**

Upon request, the lessor will provide a vehicle with a diesel engine for a fee of 250.00 CZK. The fee will not be charged if no diesel engine is available. Available only for selected vehicle groups.

#### 4-wheel drive Option

Upon request, the lessor will provide a vehicle with a 4-wheel drive car for a fee of 250.00 CZK. The fee will not be charged if no 4-whell drive car is available. Available only for selected vehicle groups.

### **Additional Driver**

A charge is levied for the additional driver, whose details are noted in the lease only if the additional driver presents a valid driver's license.

#### Vehicle refueling

Car is rented with the full tank and expected be returned with the full tank. If desired, the vehicle will be refuled according to currently available conditions after returning it to the station.

Alternatively, you may purchase a tankful of Prepaid fuel at the time of rental at a price that is competitive with local fuel stations and return the tank empty. No refunds will be given for unused fuel. Alternatively, you may book a tanking service for a fee and return the tank empty. The refueled liters will be charges at a price that is competitive with local fuel stations additionally to the prior noted tanking service fee. Subject to availability, at selected stations only.

#### **Other Fees and Taxes**

When the renter gets a CD with navigation, or portable navigation and the remote keyboard from the lessor, he is responsible for returning all the items upon the car return. The return of each item will be annotated on the contract or on the check-in list. If such a written note is missing, the renter takes the full responsibility for the items and the lessor may charge him its full price of new plus Damage Handling fee 1,500.00 CZK.

### **Premium Location Fee**

A premium location fee occurs for rentals at airport and train stations.

### **Lost Of Key or Car documentation**

A Lost Of Key Fee applies depending on the vehicle group plus Damage Handling fee 1,500.00 CZK. A Car documentation Fee applies of 3,600.00 CZK.

## **Vehicle Cleaning**

In case the car requires a special cleaning procedure (i.e. smell removal, animal pollution, spill of liquids etc.) after returning, a cleaning reinvoicing will be charge ort he minimum fee of 2,600.00 CZK will apply.

#### **Accident Handling Fee**

An Accident Handling Fee 1,500.00 CZK applies if a vehicle is damaged plus cost of repair or value of renter's responsibility signed per rental agreement.

### **Voucher print charge**

If customer needs to print any vouchers or docments, the Printing chargé of 250.00 CZK will apllies.

## **Trafic fine Fee**

In any case of the traffic violattion by car during the renters rental agreement period, the renter is obliged to pay the fine plus extra fee of 936.00 CZK.

#### **Vehicle License Fee**

A Vehicle License Fee occurs.

All rates exclude the tax/VAT (if incurred).

For corporate customers with individual agreements alternative prices and regulations can apply.
